The conditions of publication in *Macromolecular Symposia* are as follows:

1. The correspondence authors have copyright and are entitled to submit the manuscript for publication. All co-authors have been informed of the contents of the paper and its submission. The citation of unpublished results of other research groups has been authorized by them.

2. The work has not already appeared in this or in a slightly modified form in another publication, nor has it been submitted to another journal. It will not be published elsewhere within one year of its date of publication in *Macromolecular Symposia*. Please note that this restriction does not apply to the publication of a full paper incorporating the results discussed in the original *Macromolecular Symposia* article.

3. Manuscripts and original illustrations are kept by the Editorial office for six months after publication of an article, during which time they will be returned to the authors on request. Thereafter, this material will be disposed of.

4. Transfer of Rights

4.1 For the duration of the statutory term of protection, you grant us exclusive rights in all languages throughout the world, without any quantitative restrictions or restrictions regarding subject matter, for the reproduction and distribution of all versions and editions of the Work in whole or in part, in printed and/or electronic form including particularly CD-ROM, CD-I, DVD, and other electronic media, Local Area Networks, Intranets, Internet, and other data networks, and databases including rental, and transmission, broadcasting, and storage of electronic forms. If protective periods are extended in other countries, this contract shall also remain in force in that country for the extended period.

4.2 For the same period, you also assign to us the following exclusive subsidiary rights:

- a) the rights of advance publication or reprinting of the Work in whole or in part (particularly illustrations, photographs and extracts from the text) in newspapers, magazines, collections, anthologies or other periodicals or non-periodicals quoting the source
- b) the right to translate into other languages
- c) the publication rights for the Work in the form of paperbacks, reprints, school textbooks, looseleaf and bookclub editions as well as other special editions
- d) the right to reproduce the Work in whole or in part using special methods such as microcopying, photocopying, photomechanical reprinting and similar techniques, including to set up the Work for use by means of optical scanning equipment
- e) the right to redesign the Work, for example, putting it in a machine-readable form
- f) the right to use and/or process the Work in the production of a film, regardless of whether this is for screening, for broadcasting or for reproduction and distribution through the sale or hire of film copies of a specific film. In this respect it shall also be of no consequence as to which known process or system is used, or the medium and format for the film, or whether it is transmitted terrestrially, via satellite or by cable
- g) the rights to recitation, performance, and presentation
- h) all other rights protected by copyright collecting societies.

4.3 We are also entitled to transfer to third parties the partial or full rights granted to us.

4.4 If approval is required, and there is more than one author, the approval of half of all the authors shall suffice. We shall conduct negotiations regarding the assignment of rights to third parties, and shall specify the conditions.

4.5 The right to exercise and transfer subsidiary rights shall end with the termination of the principle right in accordance with Item 4.1. Licensing agreements which have already been signed shall remain in force even in the event of summary cancellation of the contract, subject to the proviso that the rights granted to us shall be transferred to you.
